WAIVER, RELEASE AND HOLD HARMLESS AGREEMENT

I have reviewed the information regarding the Greater Lafayette Recreational Soccer Alliance, Inc. ("GLRSA") and understand and agree to the policies of the league. In consideration of permission granted by GLRSA, allowing my child to participate in its league, I represent, covenant and agree, on behalf of myself and my heirs, assigns, and any other person claiming by, or under or through me, as follows:

- I know that soccer is a contact sport and a potentially hazardous activity. I am fully aware that allowing my child to participate involves certain risks (some of which I may not fully appreciate) and that injuries, death, property damage, or other harms could occur to my child or others. I recognize that my child should not participate unless my child is medically and physically able to do so, and it is my sole responsibility to determine if he/she is medically and physically able to participate in this league. I accept and voluntarily assume all risks associated with my child's voluntary participation in this sport.
- Based on my knowledge, I for myself, heirs, executors, administrators, child or anyone else who might make a claim on my behalf, covenant not to sue, WAIVE ALL CLAIMS AGAINST, AND FULLY RELEASE AND DISCHARGE GLRSA and any and all sponsors affiliated with GLRSA, participants, officials, workers, volunteers, and any and all officers, directors, employees and other representatives of the foregoing, and any successors or assigns of the foregoing (collectively, the "Releasees") from ANY AND ALL claims or liabilities, including without limitation those allegedly based on the sole or contributory negligence of any or all the Releasees, whether foreseen, or unforeseen, for death, personal injury (whether temporary or permanent), or property damage arising out of, Or in the course of, my child's participation in this league.
- I specifically agree to indemnify and hold harmless GLRSA as to any losses, liabilities, damages, costs or expenses (including but not limited to attorneys' fees and other litigation costs and expenses) incurred by any of the Releasees as a result of any claims or suits that I (or anyone claiming by, under or through me) may bring against any of the Releasees to recover any losses, liabilities, costs, damages, or expenses which arise during or result from my child's participation in this league, use of the facilities, or use of the equipment of GLRSA, regardless of whether or not caused in whole or part by the negligence of other fault of any of the Releasees.
- My signature further indicates** understanding and adherence to the GLRSA CODE OF CONDUCT below, by myself, my child/children, family, and any other guests attending. *It is the parents' responsibility that their child/children know and adhere to the Code of Conduct.*

Code of Conduct

- No player, parent or coach is to exhibit poor sportsmanship before, during, or after a game.
- No player shall "play dirty" or unfairly during the game as to deliberately try to injure another player.
- No player or parent is to argue with the referee. The referee's call is final.
- Parents are not to "coach" from the sidelines or the goals.
- Parents are asked to refrain from smoking on the fields.
- All must clean up after their pets.

Consequences

- A violation of the Code of Conduct may result in disciplinary action.
- Suspension for one or more games, or suspended permanently, depending on the severity of the offense.
 - Forfeiture of playing in a determined number of games and/or forfeit playing the remainder of the season/tournament.
 - A parent may be banned from attending child's games.
 - All decisions will be made by a majority vote of the board of directors and will be FINAL
